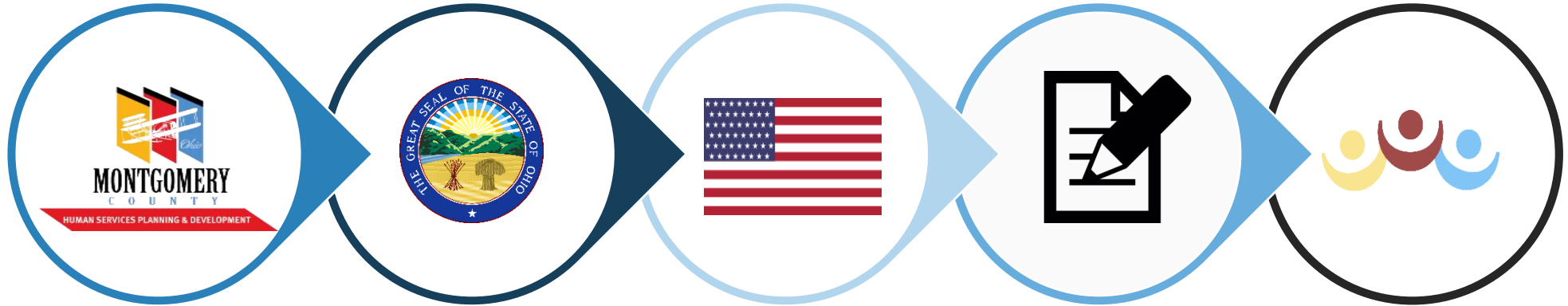

Licensure & Accreditation Requirement

Agencies requesting funding must meet at least one of the following:

- OhioMHAS licensure/certification for requested services
- National Accreditation (JCAHO, CARF, COA) for requested services



Fiscal Requirements

Financial/Insurance

- Financial Audits
 - Requires upload of most recent audit
- Insurance
 - Will require updated policies prior to contract approval
- Accounting System
- Property/Procurement Standards
- Key Performance Indicators
- No changes to Sliding Fee Scale for CY19
- Year-end Close Out: Final billing due 30 days after close of contract year.



About the Project:

Population:

Male and Female youth, between the ages of 12 and 17.9 years of age. Youth will be referred to the facility by Montgomery County Juvenile Court or the Montgomery County Children Services Division.

American Society of Addiction Medicine (ASAM) Level of Care:

Level 3.5 Clinically Managed Medium Intensity Residential Treatment – Co-Occurring Enhanced program



About the Project:

Facility Operations (4 - 10 bed units for up to 40 beds):

- a) ODJFS certified residential facility (group home): Currently operates as Nicholas Center (Montgomery County Juvenile Court) 7-10 male beds, average length of stay is 6-9 months and is dependent on individual progress and needs.
- b) Substance Use Disorder Unit: ASAM Level 3.5 Clinically Managed Medium Intensity Residential Treatment – 6-10 male & 5-10 female beds. These two units will provide both SUD & MH treatment with a maximum stay of 45 days
- c) Children Services Division Unit – ASAM Level 3.5 Clinically Managed Medium Intensity Residential Treatment – 7-10 males, average length of stay is 6-9 months but may vary based on individual needs



About the Project:

Treatment Staffing Requirements: pg. 3 & 4 in Guidelines document

Reimbursement: Agency must have the ability to bill private & public insurance

Records & Billing System: Provider must have an established Electronic Health Record System with ability to bill electronically

Care Coordination: Provider will show ability to develop and implementation multi-agency care treatment plans. Provider will submit progress reports as negotiated by the parties for each child



ADAMHS Quality Improvement Requirements

Quarterly QI reporting

- Outcomes jointly agreed upon through the AFF process by ADAMHS and the contracting agency;
- Submitted no-later than one month after the completion of the previous fiscal quarter;
- Must submit through web-based Survey Monkey portal.

Agency reviews

- Levy funded services;
- At minimum bi-annually



ADAMHS Quality Improvement Requirements

NEW CY19

E-Basis Perception of Care and Basis-24

- Distribute survey link throughout agency;
- E-Basis - 8% to 10% submission rate standard of active staff per quarter;
- Perception of Care: 8% - 10% submission rate standard of active clientele and case closures combined per quarter;
- Anticipated go-live date of March 1, 2019
 - Currently starting three phased group beta-testing

Availability & Length of Funding

- ADAMHS will provide funding on a cost reimbursement basis up to \$300,000 per year to allow the successful applicant to:
 - Provide services to youth who are not Medicaid eligible and will be reimbursed on a fee for service, claims basis through GOSH, ADAMHS electronic billing system
 - Provide non Medicaid eligible treatment and/or recovery support services,
 - Coverage for 24/7 staffing, and
 - For the first year of the grant one time administrative staff costs for up to first 3 months of the contract until program is fully operational.
- Selected proposals may be funded up to 12 months. Agreements may begin as early as April 15, 2019. Limited administrative staff (project director) need to be in place no later than April 15, 2019. Services must start May 1, 2019.
